PUBLIC NOTICE is hereby given that, on March 25, 2020, Richmond Power & Light filed with the Indiana Utility Regulatory Commission a Verified Petition seeking approval of a new schedule of electric rates and charges. The Utility Service Board of the City of Richmond, Indiana recommended by Resolution No. 1-2020 that the Common Council adopt a new schedule of rates and charges for electric service in accordance with IC 8-1.5-3-8. The recommended rates and charges are structured to reflect the results of a cost of service study. The Common Council approved the new rates and charges in Ordinance No. 11-2020, subject to approval of the Commission. The details of the filing are set forth in the Verified Petition and in testimony and exhibits filed with the Commission in Cause No. 45361, and available on the Commission's website at [www.in.gov/iurc](http://www.in.gov/iurc).
